The **CTBFC** Program is empowering voyage in understanding and combating financial crimes associated with international trade. This comprehensive program equips participants to navigate the intricate landscape of financial crime prevention, particularly within the realm of trade and commerce. It aims to address the significant risks arising from the complexity and extensiveness of the global trade making it not only vulnerable to use as a conduit for illicit funds, but also particularly challenging to protect from criminal abuse. The CTBFC Certificate is comprised of two levels. Level I (Understanding International Trade) delivers comprehensive easily yet comprehended knowledge of trade instruments flows, parties, and an introduction to key associated risks while Level II (Combating TBFC) offers a highly interactive case study immersion to offer participants

a method for both learning and applying their knowledge in a true-to-life scenario involving all aspects of TBFC. Dr. Khoury inspired graduates with his powerful message "You represent the very best of what AUB – Suliman S. Olayan School of Business stands for: learning that adapts to the world we live in."

From the Certificate in CTBFC program alone, 69 graduates were honored. It was a moment of pride

and celebration for all involved. Upon successfully obtaining the AUB Certificate in CTBFC, participants are eligible to take the MENA FCCG – GCFFC endorsed Certification exam through the AUB platform to earn the designation Certified TBFC Specialists. The Program draws upon the TBFC Guide, developed jointly by MENA FCCG and GCFFC-MENA

Chapter which was issued in October 2022. The Guide offers indepth insights into how illicit funds, goods, or services can be moved through trade flows. It has been deployed within the curriculum for the CTBFC Program. In February 2023, Central Bank of Bahrain (CBB) issued Guidance on Trade Based Money Laundering which cites this jointly developed Guide' as one of the key resources deployed in developing the CBB Guide.
